Victorian Country Football League – Eastern Area INTERCHANGE AGREEMENT



Dandenong Ranges Junior Football League Inc. & Yarra Valley Mountain District Football & Netball League Inc.

An agreement between the Dandenong Ranges Junior Football League (“DRJFL”) and the Yarra Valley Mountain District Football & Netball League (“YVMDF&NL”) for the 2010 season. It provides for the interchange of players between clubs affiliated with the DRJFL U/16 competition and YVMDF&NL U/18 competition in order to provide additional players to clubs with player shortages, subject to the following terms and conditions:

This agreement is signed pursuant to the V.C.F.L. rules and regulations pertaining to clearances and permits and in particular the Clause 2.10 – Area Permits, whereby an interchange of players between clubs of the abovementioned Leagues may take place without clearance or permits and is subject to any provisions contained within this agreement.

PROVIDED HOWEVER:

- (i) That this Agreement is in force for the current season only.
 - (ii) That the player(s) concerned are acquainted with V.C.F.L. regulations 2.1 and 2.5 regarding one day permits to Major Leagues and eight (8) matches.
 - (iii) That prior to each match played, the player shall obtain written permission to do so from his parent club. The permit shall be in triplicate similar to a one day permit form and dispersed as required under Regulation 2.1 of the V.C.F.L. Rules and Regulations.
 - (iv) With the exception of players of Junior age competitions, players of any club having a bye will not be allowed to play with another club on that day, unless he has previously played with that club in the current season under this agreement. The club playing the player from the other League shall show his registered club on the match team sheet. Players of third 18 teams of Senior Grade competitions are not to be classified as players of Junior age competitions.
 - (v) That in order for a player playing under such Area Permit to participate in a finals series in that season the player must have played a minimum of five (5) games in the team of the grade in which he has been selected to play in the finals and has met any additional league eligibility requirements.
 - (vi) That a player from either League may play with one club only of the other League during the season.
 - (vii) That this agreement cannot be altered unless agreed to by the Area Manager.
1. Prior to interchange between clubs for any match, the player shall obtain permission to do so from the club with which he wishes to interchange, and shall complete the attached “Form A”.
 2. **A YVMDFL registered player must be played before a DRJFL registered player.**
 3. No DRJFL registered player will be permitted to play in any YVMDF&NL Senior or Reserve grade matches, nor are they permitted to play in any YVMDF&NL Interleague matches.
 4. There is no restriction on the number of YVMDF&NL games played by “older age” U/16 players.
 5. No interchange permits for “First year” U/16 players (or lower age group players) will be issued.
 6. Appeals may be heard for a player who falls into Item 5 by the VCFL Regional Appeals Board.
 7. A DRJFL player can only play more than 3 games with **one** YVMDF&NL Club.
 8. A Club playing a player from the DRJFL shall show the name of the club from which the player is interchanged on the match Team Sheet.
 9. The player cannot interchange when matches of the club **to** which he wishes to interchange are played on the same day as matches of the club **from** which he wishes to interchange.
 10. The player cannot interchange on the same weekend when he is selected to play an Interleague match for the DRJFL. (weekend includes Friday night)

11. The player cannot play for a YVMDF&NL club if his DRJFL club is participating in home/away match on the same day.
12. Players who are reported for a field offence shall have the charge heard by the Independent Tribunal of the League within which the offence occurred. In the event of finding the player guilty, this Tribunal shall determine the penalty, the duration of which is to be served in the League in which the player is registered. The suspended player is ineligible to play in either League during the term of his suspension. Leagues shall immediately notify details to the other League of any suspension imposed upon an interchange player.
13. A copy of the U/18 team sheet in which the permitted player appears shall be sent to the Secretary of the DRJFL within the week following the permitted game.
14. Interchange can be revoked at any time at the discretion of the DRJFL and the YVMDFL.
